

# ELVEDEN PARISH COUNCIL

## Minutes of the Meeting of the Parish Council held on Wednesday, 9<sup>th</sup> October 2024, at 7.30pm in Elveden Estate Office Conference Room

Present: Cllrs Rob Minty, Rebecca Younge and Hugo Nugent. Also in attendance, Cllr Victor Lukaniuk and Cllr Gerald Kelly.

1. **APOLOGIES** There were none.
2. **MINUTES OF THE PREVIOUS MEETING.**  
The minutes of the previous meeting held on Wednesday, 17<sup>th</sup> July were agreed and signed as a true record.
3. **MATTERS ARISING (Not on the agenda)**  
There were none.
4. **REPORTS AND PUBLIC PARTICIPATION**  
The council received reports from Cllr Lukaniuk and Cllr Kelly. No members of the public were present.
5. **DEFIBRILLATOR**  
Due to a change of government, the defibrillator grant scheme had been withdrawn. The Estate had purchased several defibrillators for various locations around the parish.
6. **VEHICLE ACTIVATED SPEED SIGN AND SPEED REDUCTION MEASURES**  
The Clerk reported that the application for the Temporary Vehicle Activated Sign (TVAS) had been successful and the TVAS had already been deployed on Old London Road. This was in addition to the speed enforcement carried out on the B1106 within the village. The reinstatement of the speed limit roundels on Old London Road and the B1106 had also been agreed. The council thanked Cllr Lukaniuk for providing funding for this project from his locality budget.
7. **RURAL CRIME**  
The police were not present. The Clerk reported that between April and August there had been 17 recorded crimes within the parish. Of those crimes, 14 were within Centre Parcs.
